**Roscommon County Hazard Mitigation Plan Adoption Resolution**  
**Resolution No. 2023-4**

Whereas Higgins Township, Michigan has experienced risks that may damage commercial, residential, and public properties, displace citizens and businesses, close streets and impair infrastructure, and present general public health and safety concerns; and

Whereas the community of Higgins Township has prepared a *Hazard Mitigation Plan* that outlines the community's options to reduce damages and impacts from natural and technological hazards; and

Whereas the *Hazard Mitigation Plan* has been reviewed by community residents, business owners, and federal, state, and local agencies, and has been revised where appropriate to reflect their concerns;

Now, therefore, be it resolved that:

The *Hazard Mitigation Plan* is hereby adopted as an official plan of Higgins Township.

Roscommon County Emergency Management is charged with supervising the implementation of the Plan's recommendations within the funding limitations as provided by Roscommon County or other sources.
