Higgins Township Building Permit Fees

Residential Building

Single family dwelling, garages, sheds, pole barns, carports, additions, basements, 2nd floors-remodel, alter, porches, decks, roof over modulars, mobiles, new foundations under existing structures.

Base fee: \$50.00

Zoning fee: \$40.00

Plus \$0.20/sq foot (min. fee: \$60.00)

Building Permit: Construction work must be started within 6 months of date of

issue. Permit valid for one year.

Renewal: Permit may be renewed ½ permit cost for 6 months.

Outbuildings: up to 200 sq feet no permit required, \$40.00 zoning fee only.

Solid fences 6 feet or higher: \$60.00

Demolition permits: \$50.00

Plan review: \$25.00

Reinspection fee: \$35.00

Mobile Home Regulations:

Must have electric, water, and sewer hook-ups before mobile home may be moved in. Must be on 4" slab, the size of which equals the size of the home with tie downs every 8 feet. The mobile home must be skirted and the wheels and tongue must be removed.

Occupancy Permits: must be complete.
